### Health Guarantee

We are committed to providing top quality Multigenerational Australian Labradoodles. In doing so, we only breed our dogs once they have passed, and done well on health testing. The health of your new ALOT pup is extremely important to us.

### BREEDER'S RESPONSIBILITY:

- The Breeder guarantees the puppy/dog is in good health at the time of delivery or pick up. If the puppy is found to be in poor health with a life threatening condition the Buyer has the option of returning the puppy to the breeder within three days of delivery or pick up for a full refund of purchase price. Proof of condition will be provided in writing to ALOT from a vet.
- The Breeder provides a two year warranty after the date of sale against any life threatening genetic disorder that is life threatening. Should a serious genetic disorder be discovered, the Breeder will offer a replacement puppy from the next available litter. Your puppy does not need to be returned to us. All veterinary records must be supplied to the Breeder. In the case of HD (Hip Dysplasia) the Buyer must provide documentation from OFA (at buyer's expense). If the dog has HD due to the buyer allowing dog to become overweight or excessive exercise or jumping during puppies 1st year, or an accident the buyer will take responsibility. In the case of PRA (Progressive Retinol Atrophy) the Buyer must provide documentation from a veterinary ophthalmologist (buyer's expense).
- The Breeder reserves the right, at the Breeder's expense, to have the dog checked by a veterinarian of the Breeder's choice before offering a replacement puppy.
- The dog is only guaranteed to the original purchaser. If the dog has been sold, the health guarantee becomes null and void.

### BUYER'S RESPONSIBILITY:

- The Buyer will provide the dog a caring home.
- The Buyer will take the dog to a veterinarian for an annual check-up, and all preventative treatment recommended by the veterinarian will be followed.
- The Buyer will take the dog to either group or private training classes by the time the dog is five months of age. The buyer understands normal tendency to nip, chew and bark is the responsibility of the owner to eliminate any unwanted behavior through training and is not a reason to return puppy.
- The buyer will feed the dog only premium quality dog food. Pet food sold in grocery stores does not constitute a premium pet food.
- The Buyer will not allow the dog to become overweight or allow repetitive, rigorous exercise during the first year of development.
- The Buyer will make every effort to keep puppy/dog in a calm, quiet environment for the first five days of receiving puppy/dog. This will help make transition for puppy easier and less stressful until he is used to his new family and home.

### BUYER AGREES TO:

1. Pay the Seller a total sum of \$3,500
2. Buy the puppy as a companion pet only, NOT FOR BREEDING purposes.
3. House their dog indoors.
4. Contact the Seller immediately if they determine they are unable to keep their dog for any reason. The dog is to be returned to Seller at Buyer's expense.
5. Never place their dog in a shelter, pound or similar facilities, or research laboratory.
6. Spay or Neuter their dog by 12 months

This warranty does not include viral illnesses, infections, improper bites, hernias, hypoglycemia, Guardia or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.
